Assessor's Report:

Assessor's contract has expired, and she has sent over a new contract. She would like to get a cost of living increase.

Fire Authority Report:

The discussion of the new fire truck continues. K. Hummerickhouse is supposed to be meeting with the sales rep soon, but he has been informed that the truck would take 2 years to produce. Estimated cost is somewhere between \$600000.00 and \$800000.00.

Sims-Whitney Utilities Authority Report:

The new membranes for the filters are not going to be here until sometime in June.

Sims Whitney Cemetery/Transfer Station Report:

We gave employees a raise at both places of \$1.00/hour.

The budget was approved, we approved more stone for the Transfer Station and Cemetery, discussed the grants being submitted to Tribal Council, and many other things.

Public Comment:

What is being done on 23? It is going to be ground up and resurfaced, with all the bumps hopefully being addressed.

Old Business:

Quote on Lighting for Hall- We haven't received the quote from the electrician that came in.

Survey- The price for SSI's survey is going to be \$2350.00, Anderson has not heard back from Riggs and will call again to try and get an answer.

New Business:

Local Control Issue- McAlindon printed a resolution that was sent from a group trying to preserve local control for Townships. No decision needs to be made and can be discussed again next month.

Solar Ordinance- Planning Commission is trying to get a Solar Ordinance in place for large solar farms, we keep running into road blocks in the process.

A resident asked a question about what constitutes blight. Anderson is going to get her a copy of the ordinance.
